

The debt coverage ratio measures the University's available cash flow to pay current debt obligations.





Endowment Return and Spending Rate Comparison



Endowment Support as a Percentage of Total Operations






Overall Compensation as a Proportion of the Operating Budget

#### AS OF JUNE 30, 2023 Year Six of Campaign








Top 5 Minors - 22-23 Graduates






Yield (Conversion Rate): The proportion of students who enroll after being accepted to the University.




According to U.S. News (2022) **61%** of all graduates leave university with student loan debt. **56%** of Southwestern 22-23 graduates had student loan debt.
