



Key Financial Dates and Deadlines

Since the financial responsibilities of students and families are very important, this document outlines all key dates and deadlines. Your student agreed to take financial responsibility for their classes by agreeing to the Southwestern University Payment Terms and Conditions during the registration process. Students who have not made satisfactory payment arrangements to cover their account balances WILL NOT be able to move on campus and will have their classes cancelled.

Vehicle Registration</p> <ul style="list-style-type: none"> ■ All Southwestern students are automatically charged a Vehicle Registration of \$120 per semester. ■ If a student does not park a vehicle on campus, the charge may be waived EACH SEMESTER by the student completing the Vehicle Registration Waiver form online. <p>2. EIIA Health Insurance Waiver</p> <ul style="list-style-type: none"> ■ All students are required to have health insurance as a condition of enrollment. ■ All student accounts will be charged an annual premium amount of TBD for SU’s student health insurance plan. ■ For students who are already covered under another health insurance plan, this annual charge can be waived online by providing evidence of the primary insurance plan <p>3. Dewar Tuition Refund Plan Waiver</p> <ul style="list-style-type: none"> ■ All students are charged an annual amount of \$TBD for the Dewar tuition refund plan to supplement SU’s refund policy. ■ This optional annual charge can be waived on-line.
TBD	All students taking the SU Student Health Insurance are strongly urged to complete the “Early Enrollment” process so that their insurance cards will be available on the effective date of August 10, 2026. Please note that students who do not complete the early enrollment process will not have access to their insurance card until September.

7/09/26	Last Day to Submit all Fall Waivers - EIIA Health Insurance, Dewar Tuition Refund Plan and Vehicle Registration. Visit southwestern.edu/business-office/student-accounts/waivers-for-optional-charges to waive any of these fees.

7/10/26	Fall 2026 Tuition Due
7/20/26	Unpaid Student Account Balances are past due and \$150 Late Fee assessed (includes non-payment for Dewar Tuition Insurance, EIIA Student Health Insurance and Vehicle Registrations).
8/14/26	Classes cancelled for students with unpaid balances.
8/15/26	First-year students move into on-campus housing (Students with unpaid balances will not be allowed to move in.)
8/21/26	Move In for Returning Students (Tentative Date)
8/24/26	Classes Begin for Fall 2026
11/20/26	Release Spring 2027 E-Bills & Payment Plan Enrollment Opens
12/10/26	Last Day to Submit Applicable Spring Waivers - For most students only the Vehicle Registration waiver is applicable. For new SU students for Spring 2027, this applies to EIIA Health Insurance, Dewar Tuition Refund Plan and Vehicle Registration. 12/18/26	Unpaid Student Account Balances are past due and \$150 Late Fee assessed at the end of the day (includes non-payment for Dewar Tuition Insurance, EIIA Student Health Insurance and Vehicle Registration).
1/08/27	Classes cancelled for students with unpaid balances.
1/16/27	Move In for Returning Students (Tentative Date)
1/19/27	Classes Begin for Spring 2027
